

DO'S AND DONT'S:

Membership Rules:

- All club members agree to be bound by the club fees and charges. The club reserves the right to alter these charges as required.
- Membership offers:
 1. Identity Card (Beginners, Intermediate, Advance).
 2. T-shirt of ZEAL CYBORG ROBOCLUB.
 3. Can attend various workshops, Seminars & Lectures.
 4. Can access computer with high speed internet.
 5. Can utilize the tools required for any robotic event.
 6. Electronic accessories will be provided by club for event.
 7. Can share and download the TED and NPTEL videos.
- **Your club card is for your own use only.**
- Every member shall promptly notify the club of any change of address or contact information.
- If you lose your card, a replacement card can be issued for a small charge, but you will be responsible for any components taken out on missing cards until you report the loss.

Note:

If any component is lost, or returned in a damaged or defaced condition, the borrower shall pay to the club a sum of money as will replace that component or pay full compensation for any damage or loss incurred by the club. A component may be deemed lost by an Issuer one month after the date on which it was due to be returned to the club.

Borrowing periods:

Defined by the governing authority.

Terms and Conditions:

- Club users must have their club card in the lab premises.
- Club users must present their club card each time they borrow a component.
- Club users are responsible for all components borrowed using their membership cards.
- Any furniture, fittings or equipment in robo club must not be misused or their arrangement altered. Authorisation is required for the removal of any club property from the building.
- Club users may be asked to present their bag for inspection by club staff, as well as any folders they are carrying.
- Club users are required to keep all borrowed components clean and to provide adequate protection for them. They must not lend the components to a third party, nor mark, deface or damage components. Audio-visual materials must be maintained in a good condition.
- You must return your components to club on or before midnight on the date due back. If you keep components beyond that date, you will be charged in line with the current rate of charges.

If you:

- (a) Do not pay your club overdue charges, or
- (b) Do not return components that are long overdue, or
- (c) Have not paid for or replaced any lost or damaged component you may not be allowed to borrow further components. The circumstances may also be reported to the Club Staff, who has the authority to cancel the membership of any person habitually keeping components overdue, treating them badly or refusing to pay fines or outstanding charges.

Any person entering a club must not:

1. Behave in a manner that creates a nuisance or is offensive to any other person
2. Bring into the club or exhibit any article that is a nuisance or is offensive to any other person
3. Damage any club property

The use by any person of any club service or facility must be for legal purposes, and must not result in breach of copyright, breach of privacy rights, unauthorised alteration or deletion of data or website contents, unauthorised access to information or the access or transmission of illegal images or text.
