• AMS does not look at the training programmes to earn only money but to cater today's requirement and needs of society and country to train and educate the students for their better life in their placement and carrier.

- AMS will arrange their own Training programme on Basic Metrology either in AMS Kolhapur or in **ZES** Pune for 3 days. In case the programme is conducted in Kolhapur, AMS will charge fees for training programme for 3 days per participant Rs. 2000/- + GST applicable which includes Morning and Afternoon tea and lunch in noon, certificate & CD as a work material.

This Memorandum of Understanding (MOU) is made on October 14th 2019 at Pune

By and Between:

This MOU is between KUL Foundation for social Initiative (hereinafter referred as KUL Foundation) having H.O. KUL Foundation for Social Initiative, 2409, Juna Pulgate near to Grand Café, Opposite to Methodist Church, E-street Pune-411001 (hereinafter referred as Foundation) Engi

AND

Zeal Education Society (ZES) located at S.N.39, Katraj Dhayari Road, Narhe, Pune echanical 411041

ZES and KUL Foundation shall hereinafter individually be referred to as "Party" and collectively as "Parties".

WHEREAS:

- A. KUL Foundation as part of its corporate social responsibility program, to be implemented in accordance with the provisions of the Companies Act, 2013 and the rules, regulations, clarifications and directions thereunder, as amended from time to time (the "Companies Act"), is desirous of contributing towards promoting Entrepreneurship Development Program through engaging in partnerships and programs with Educational Institutions/ Non-Governmental Organizations ('NGO') to promote budding and existing entrepreneurs in India and to provide a good learning & development environment to youths to ensure their overall development especially for disadvantaged sections of society as well as provide mentoring & incubation support to the organisation engaged in similar activities.
- B. ZES is engaged in education for candidates.
- **C. ZES** under its Corporate Social Responsibility (CSR) activities, has agreed for to collaborate for the EDP project of the KUL Foundation as joint responsibility for conducting training for Budding Entrepreneurs.
- D. The Parties, therefore, desire to enter into this Memorandum of Understanding (MOU) to record the terms and conditions regarding the provisions of the CSR activities and funding for the aforementioned project.

1. <u>Term</u>

Each Party shall hold all the information of the other Party strictly confidential, whether comes to the knowledge of such Party through a written document or in oral form. "Confidential information" shall mean any/all information which is not in public domain and that would ordinarily and without breach of any legal obligation, not be known to any person who is not having any relationship with the Party concerned or any proprietary information of Parties, whether of a technical nature or any other sensitive information, including but not limited to all inventions, disclosures, processes, ideas, systems, course content, methods, formulae, devices, intellectual properties, instruments, know how, improvements, materials, products, patterns, compilations, data, programs, techniques, sequences, designs, research or development activities and plans, licenses, specifications, computer programs, source and object codes, mask works, works of authorship, costs of production, prices or other financial data, volume of sales, promotional methods, lists of names or classes of clients/ customers or personnel, lists of suppliers, business plans, budgets, business opportunities, financial statements or information related to a Party concerned. All such information shall be referred to as Confidential Information with reference to this MOU.

11. Governance

- b) This MOU can be terminated by either Party upon serving thirty (30) days' notice without assigning any reason thereof.
- c) On termination of this MOU for any other reason except expiry due to efflux of time, -KUL shall cease to use/associate Partner Organisation brand or name with the Project and shall refrain from using any of the Company's intellectual property in any manner.

- d) The provisions of this MOU shall be binding upon and inure to the benefit of the Parties hereto and their respective successors and permitted assigns.
- e) This MOU constitutes the entire MOU between the Parties with respect to the subject matter hereof and supersedes all prior agreements, understandings and negotiations, both written and oral, between the Parties with respect to the subject matter of this MOU. No representation, inducement, promise, understanding, condition or warranty not set forth herein has been made or relied upon by any Party hereto.
- f) Neither this MOU nor any provision hereof is intended to confer upon any person other than the Parties to this MOU any rights or remedies hereunder.
- g) This MOU and all terms and conditions contained under it shall be binding on both the Parties.
- h) This MOU shall be governed under the laws of India and subject to below conditions, the courts of Pune, alone shall have exclusive jurisdiction for all disputes under this MOU.
- i) In the event of any dispute or difference arising at any time between the parties hereto as to the construction, meaning or effect of this MOU or any clause or thing contained herein or the rights, duties, liabilities and obligations of the Parties hereto in relation to the premises the same shall be referred to Arbitration in accordance with the Arbitration and Conciliation Act, 1996 as amended from time to time. All such arbitration proceedings shall be held in Pune. The costs and charges for Arbitration shall be borne by the Parties in equal proportion.

14. Force Majeure

Neither Party shall be liable for any delay or failure in performing any of its obligations hereunder, if such delay or failure is, either wholly or partly, due to force majeure conditions such as floods, earthquakes or other acts of God, or any acts of any governmental body or public enemy, wars, riots, terrorism, embargoes, epidemics, fires or any other similar causes, circumstances or contingencies beyond the control of such Party and provided always that any such alleged force majeure event should not have occurred due to the own fault of a Party.

The Party affected by such force majeure condition shall notify in writing the other Party of the nature and extent thereof, and shall, to the extent reasonable and lawful under the circumstances, use its best efforts to remove or remedy such cause as soon as possible.



If the force majeure condition in question prevails for a continuous period of 14 days, the Parties shall enter into bona fide discussion with a view to alleviating its effect on this MOU by agreeing to such alternative arrangement as may be fair and reasonable.

Their journey was started end of November, when we have started our pilot 3 months EDP in Aurangabd with 16 candidates, then in the first week of December at Kolhapur with 34 candidates & in Pune with 20 candidates.

The selection of candidate was made through Mobilization, after Socio Economic test & other tests inclusive but not restricted to group discussion, personal interview, to check whether the selected candidates have real spark to start their own.

As our CMD says, the candidate should have vision to start something innovative, which should be viable for at least 5 years, generate employment for minimum 5 resources, & importantly to inculcate & develop entrepreneurship attitude at various levels of society.

Our actual journey started in the month of June with 2 months Training of Trainers' (TOT) program for 7 trainers. These trainers gone through rigorous training of Business Cycle like Identification of Business Idea, Initial Market Orientation, Market Visit, Business Validation, Business Strategy, Verification of Business, Feasibility & Risk study, Competitors' analysis, Business Standardization & preparing Business Plan.

At the end of TOT, all trainers have presented their Business Plan to our CMD with Business Contingency Plan, Funding opportunities, Funding Agencies, Govt. Schemes- MSMED, Bankable Project by adding Working Capital and Costing & Pricing.

While formulating these presentations all trainers have given their quality time for finalizing EDP curriculum which was in turn helpful to run 3 months' pilot EDP, without any hindrance. The Visiting faculties & the successful Entrepreneurs, who visited our EDPs, also have appreciated the efforts taken by our team in preparing the Schedule, Topics, activities/exercise, self-learning videos& the contents.

We are thankful to all 3 Institutes, Vivekanand College- Aurangabad, Sanjay Ghodawat Institute-Kolhapur & Zeal Institute- Narhe Pune, with whom we have initially done MOU for using their classroom & other facilities for our EDP.
